Dear Mrs. Bratt,

Thank you for welcoming Inta Duce from the external monitoring team on 28 April 2022 at the premises of Lund University. The meeting was well organised and provided good insight into the project's current technical status. Please extend my thanks also to the representatives of the associated beneficiaries for their active participation in the meeting.

I am very pleased to note that the Land and Environmental Court of Appeal on 18 February 2022 granted the permission to move the waste-water discharge point to Ågårdssbron (River Lidan), as initially planned by the project. I understand that the next important step is to receive the approval of the WWTP from the municipal council, and that is expected in June 2022. You expect that after this approval the project will be able to start its technical implementation at full speed.

I note that you are planning to propose the prolongation of the project by at least 36 months. This is a substantial change in the sense of the LIFE General Conditions; therefore, I invite you to submit a formal request for an amendment to CINEA as soon as possible in order to avoid further delays in the project. Please work closely with your external monitor on the preparation of the request before it is submitted to CINEA. Please find the general guidelines for the presentation of an amendment to the grant agreement on the CINEA website at https://cinea.ec.europa.eu/programmes/life/contract-and-financial-aspects_en.
